Hello, Vikings!

The Members of the IOV Executive Council would like to say THANK YOU for your patience over these past several months, as we work to secure the future of IOV. We want to take a few minutes to bring everyone up to speed.

Plan A

As you may recall, IOV delegates approved the insurance surrender process at the June 2017 Convention. Closing the insurance program was an attempt to change IOV's legal (IRS/tax) standing from a Fraternal Benefit Society to a Fraternal Society, allowing us to exit the insurance business and continue the fraternal activities we all value and enjoy. This was the course suggested by our insurance administrators during the convention discussion. When the idea was presented to the Illinois Department of Insurance (IDOI, the government body with the final say about IOV's plans), they said they had not seen this type of conversion done before but they were willing to work with us. We were excited! We thought we had found the answer. But as we worked through this process we have learned, for several reasons, it will not be possible to close the insurance program as planned.

The Road Block

IOV has nearly 700 insurance policies remaining. Between policy holders we cannot locate and those individuals who cannot (or will not) surrender, we will not achieve a 100% surrender rate – even after considering those who have indicated their willingness still to surrender. 100% surrender is the rate we must achieve, which was not evident in the beginning of the process. IOV's recent pause in surrender activity – to audit the number, value and type of policies remaining – came as we were working with lawyers from Locke Lord LLC (based in Chicago) to determine other options IOV may have, since Plan A is not going to work.

We have to deal with the reality of our financial forecast, which is concerning: our existing insurance policies do not generate enough revenue to support the insurance operations, and IOV is losing money on an annual basis through insurance administration fees. If we don't make significant changes, IOV will be forced to close in as few as five years. **This is not "new"** – it is the reason that the 2017 Convention delegates voted to pursue surrenders, in the hopes of providing a long life for the IOV.

Plan B

We are now exploring Plan B, a possible relationship with a national insurance company who will service IOV's remaining insurance policies while allowing the IOV fraternal structure to continue. In this relationship, IOV would continue to add members as "social" members (uninsured), and the insurance company would promote their products to all members. Vikings would receive periodic communication from the insurance company, much like you do from a credit union or AARP. **AN IMPORTANT NOTE:** marketing this new company's financial products to Viking members will be part of the deal. Uninsured IOV members will **NOT** be required to purchase an insurance policy for IOV membership, but they will have that option if they choose to pursue it.

What's Next?

We are in the exploration and information seeking phase of Plan B (due diligence) and Council Members had to approve a **confidential non-disclosure agreement**. This means we **cannot** divulge the name of the company or any details about the potential partnership until both parties agree that we have sufficient agreement to "go public." We will provide more complete details as soon as we can. If Plan B turns out to be the Executive Councils recommended course, a formal proposal will be presented for a special meeting with lodge delegates sometime this summer. We will be in contact with lodge leadership and the delegates themselves when the time comes and will provide a minimum of 30-days written notice, as required by the IOV Constitution. (It is highly unlikely that we will be ready by June 19, so that date can be released.)

Please know the Executive Council and many volunteers have been working very hard to close the insurance program as approved at the 2017 Convention. We reached out to lodges for their assistance and have printed multiple notices in the Journal. Many of our Viking members willingly surrendered their insurance for the good of the Order. We greatly appreciate everyone's efforts! After all this, it has been extremely frustrating to learn that Plan A is not possible. We are now working through the details to find the best path forward. From a financial standpoint, we simply cannot continue "business as usual" without putting the IOV in jeopardy. Plan B has great potential. **Our #1 goal is to ensure the IOV will continue and to grow.** We are working as hard and as fast as we can, in service to you.



Burn Camp Update


Great Lakes Burn Camp:
